Upon facts and circumstances, defendant, its directors, partners or proprietor, as the case may be, assignees in business franchisees, licensees, distributors, dealers and agents from in any manner are hereby restrained <u>till</u> <u>further orders</u> from using METRO, METRO HEART INSTITUTE and METRO HOSPITAL trade name/ trademark or any other name which include the name METRO or any of its part.

Compliance u/o 39 rule 3 CPC be made within a week from today. Copy of this order be given dasti as prayed. **This ex-parte ad interim order will operate from the time it is served upon defendant and notice of the application.**
