2. The Applicant company M/s Sun Pharmaceutical Industries Limited was incorporated on 01.03.1993 with the Registrar of Companies, Gujarat, Ahmedabad and has obtained Trade Mark Registration for the mark and word "SUN" under the Trade Mark Act, 1999. The Respondent Company M/s Sunvita Pharmaceuticals Private Limited was incorporated on 09.10.2015 with the Registrar of Companies, Kanpur, Uttar Pradesh having its registered office at 9/11, South Lokpur, Naini, Allahabad, Uttar Pradesh- 211008.

3. On receiving the application from the Applicant, this office has called comments from the Respondent Company and fixed the matter for hearing on 20.11.2017. This Office has also called comments of the Registrar of Companies, Kanpur, Uttar Pradesh, vide letter dated 24.10.2017. On hearing dated 20.11.2017 the Authorized Representative of both the Applicant Company and Respondent present for hearing and Mr. Shashwat Singhal, Chartered Accountant, authorized representative of the Respondent Company submitted that Respondent Company is ready to change its name and requested some time for the same. Considering the request of Respondent matter adjourned to 13.12.2017. On hearing dated 13.12.2017 the authorized representative of the Respondent present for hearing but authorized representative of the Applicant sought adjournment for his appearance and in the interest of justice matter adjourned for hearing on 24.01.2018.

4. During the hearing on 24.01.2018 Mr. Shashwat Singhal, Chartered Accountant on behalf of the Respondent Company has informed that they are willing to change the name of the Respondent Company and will start the process for change of name within the time prescribed by this forum, which makes their stand ample clear for change of name and the Authorized Representative for the Applicant Company does not have any objection in this regard.

Therefore, by considering the above facts and circumstances and in terms of provisions under sub-section (1)(a) of section 16 of the Companies Act, 2013 read with Government of India, Ministry of Corporate Affairs Notification no. S.O.4090 (E) dated 19.12.2016, I am inclined to accept the submission of respondent company with direction to change its name within three months from date of this Order. Accordingly the application for rectification/change of name by Applicant Company is allowed and disposed off with no order to cost.
