**3.** In view of the order being passed today, this application has rendered infructuous and is disposed of.

4. The plaintiff is the registered holder of the mark "NORMOZ", under which mark it manufactures and clears a pharmaceutical preparation containing Inositol, Chromium Picolinate and Vitamin D3, stated to be useful in the treatment of Polycystic Ovarian Syndrome (PCOS).

- 5. The plaintiff alleges that the defendant is infringing the plaintiff's registered mark and passing off its products as those of the plaintiff by manufacturing and selling a pharmaceutical preparation containing the same constituents under the name "NORMOCOS".

- **10.** Issue notice. Notice be served on the defendants by all modes.
- **11.** Notice on Defendant 2 be additionally served *dasti*.

- **13.** Re-notify on 22<sup>nd</sup> December 2022 before the Court for disposal of these applications.
